##### MOBILITY TYPES

**Student Mobility for Studies:** Students can undertake mobility for studies in one of the partner higher education institutions abroad as part of their diploma programme at any level of study

**Student Mobility for Traineeships:** Students can carry out a traineeship at a business, research institute, laboratory, organization, or any other relevant workplace abroad.



Traineeships abroad are supported for studies at all academic levels, as well as for recent graduates. The traineeship must be an integral part of the student's study program.

#### MINIMUM AND MAXIMUM DURATIONS FOR A SINGLE MOBILITY

Mobilities are carried out in accordance with the minimum and maximum periods determined by the European Commission.

##### **Mobility for Studies**

The minimum period is 2 full months or 1 trimester and the maximum period is 12 full months.

##### **Mobility for Traineeships**

The minimum duration is 2 full months, and the maximum duration is 12 full months. Post-graduation traineeships must be completed within 12 months of the graduation date.

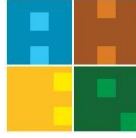
#### APPLICATION REQUIREMENTS

In order to participate in the activity, students must first meet the following minimum requirements:

- 1- The student must be a **full-time** student enrolled in a higher education programme at any of the formal education levels within the higher education institution,
- 2- a) The cumulative academic grade point average of the first cycle students must be at least **2.20/4.00**,  
b) The cumulative academic grade point average of first cycle students must be at least **2.50/4.00**  
c) Second and third-cycle students must have a minimum cumulative academic GPA of **2.50/4.00**.
- 3- Sufficient number of ECTS credits for mobility for studies (60 ECTS credits for one academic year).

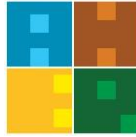

<sup>1</sup>In uses and children of war martyrs, according to Article 21 of the Anti-Terrorism act to combat veterans and their spouses and children and the spoorism Law No. 3713 dated 12/4/1991, Article 21 of the Anti-Terrorism Law No. 3713, 'public officials who have been injured, disabled, killed or killed as a result of terrorist acts while performing their duties at home or abroad or due to the performance of these duties, even if their titles have been removed', and the spouses and children of those who lost their lives due to the coup attempt and terrorist act carried out on 23 July 2016 and the follow-up actions of this act, or the spouses and children of civilians who have been disabled, and the spouses and children of those persons. <sup>3</sup>This includes internships that provide experience in one or more of the following activities: digital marketing (e.g. social media management, web analytics), digital graphic, mechanical and architectural design; application, software and code or website development; installation, maintenance and management of information systems and networks, cyber security, data analytics, data mining and visualisation; programming, robotics and artificial intelligence training. This **does not include** general customer service, demand generation, data entry or routine office tasks.



\* When calculating the Erasmus score of students who have previously benefited from higher education student or internship mobility within the scope of Erasmus+ (2014-2020 or 2021-2027) within the same education level, a 10-point deduction is applied for each previously benefited activity. (regardless of study-internship If a student who has benefited from mobility before applies for both study and internship activities at the same time '-20) points are deducted from the second type of mobility he/she benefited from before and '-10' points are deducted from the second type of mobility he/she applies for.

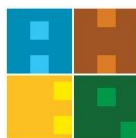
## GRANT AMOUNTS

Erasmus Grant is a non-refundable financial support given to students who go abroad with the Erasmus+ programme **as long as they fulfil their Erasmus+ obligations.** Monthly Erasmus+ grant amounts are determined by the National Agency separately for each country group according to living standards. The grant is intended to support the educational activity carried out and **does not cover all expenses of the student**

### *Student/New Graduate Mobility to Programme Countries*

The table of individual support grant amounts to be applied when sending students/new graduates to the programme countries is given below

## **Travel Support**

To contribute to students' travel expenses, the distance between the starting point of the mobility and the location where the activity will take place should be determined using the distance calculator provided by the European Commission ([http://ec.europa.eu/programmes/erasmus-plus/tools/distance\\_en.htm](http://ec.europa.eu/programmes/erasmus-plus/tools/distance_en.htm)). The travel grant should then be calculated using the table below. The distance value from the calculator corresponds to the round-trip amount in the table below and should not be doubled.

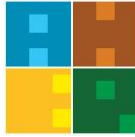

### **GRANT DEDUCTION**

- If students return before the minimum period is completed, except for force majeure, the activity will be deemed invalid, and the grant will not be paid.
- The University Erasmus+ Selection Commission decides whether to cut the grants of students who do not fulfil their responsibilities and/or fail.

### **IMPORTANT NOTES**

- It is possible to benefit from the program of Erasmus + mobility programmes (Mobility for Studies and Mobility for Traineeship) with or without grant.
- The fact that the student retakes a failed course does not prevent students from applying for an Erasmus +mobility.
- Student mobility for studies is carried out within the framework of existing inter-institutional agreements of ECHE and the Higher Education Institution.
- Bilateral agreement of departments is not obligatory if students want to benefit from the Erasmus +Traineeship Mobility programme. Students can apply and take the language exam by selecting the traineeship option only.
- Each student can benefit from a maximum of 12 months of studying and / or traineeship activity with or without grants, including the duration of the activity he / she has previously used in each level of education (undergraduate, graduate, doctorate) under Erasmus+ Programme.
- Traineeship Mobility can be carried out in every grade during the education period and within 12 months after the students in the final year of their education programs graduate. The application for the internship activity to be carried out after graduation must be made before the student graduates (while he/she is currently an associate, undergraduate or graduate student). Graduated students cannot apply. Post-graduation internship mobility must be completed within 12 months from the date of graduation. The total of the internship period



after graduation and the student's mobility period at the same level should not exceed 12 months.

- Academic recognition is provided for credits achieved in the program; Failed courses need to be taken at Alanya University.
- Students who have been selected for mobility but want to waive are required to notify the International Relations Office within 10 working days after their election is announced to avoid any reduction in their next application.
- Students studying in a double major can apply for mobility from only one major during the same application period.
- Students who suspend their registration cannot carry out their educational mobility or compulsory internships during the period they suspend their registration. It is at the discretion of the higher education institution whether a student who suspends registration for optional internships can benefit from mobility. Applications for study or internship mobility can be made during the registration freeze period.
- If students return before the minimum period is completed, except for force majeure, the activity will be deemed invalid and the grant will not be paid.
- Each student in the application will be deemed to have accepted the terms and conditions contained in the Erasmus + Guidebook and any disputes that may arise will be decided according to the information in the relevant documents.
