ISSUES RELATED TO THE APPLICATION

1. Applications for the Institute of Graduate Studies, 2026-2027 Academic Year Fall Semester will take place between 22 JUNE 2026-31 JULY 2026. It will take place between dates. Prospective students can apply to graduate programs through the application link available at: https://sis.alanyauniversity.edu.tr/oibs/ina_app/
2. Graduates of our university or higher education institutions other than our university students' grade conversions are made based on the YÖK Grade Conversion Table (<https://oyp.yok.gov.tr/Documents/Anasayfa/4lukSistem.pdf>).
3. **Applications of candidates with missing or incorrect documents in the online application will be deemed invalid.**
4. A “Scientific Preparation Program”, the scope and duration of which will be determined by the relevant department, may be mandatory for students who have not graduated from the related field.
5. Some documents, such as Working Documents, CVs, Reference Letters, Portfolios, Theses, Equivalence or Recognition Certificates, etc., required by the special conditions of some programs must be uploaded to the additional document area of the online application system.

DOCUMENTS REQUIRED FOR APPLICATION (FOR APPLICANTS WHO ARE CITIZENS OF THE REPUBLIC OF TURKEY)

The following documents must be scanned and uploaded to the system during the online application. Candidates must bring the originals of the documents uploaded to the system with them during the exam/interview.

1. **Diploma:** For master's degree applicants, a bachelor's degree diploma or graduation certificate. (You can also apply with a Temporary Graduation Certificate or a graduation certificate obtained from e-Government.)
2. **Transcript:** For master's degree applications, documents showing bachelor's courses and grades.
3. **ALES Certificate:** ALES exam result certificate. (This document is not required for applicants to non-thesis master's programs and international students)

4. **Foreign Language Certificate:** YDS or an equivalent exam result certificate. (This document is required for applicants to master's programs specified in the General Application Conditions.)
5. **Equivalence/Recognition Certificate:** Turkish citizens who have completed their education in foreign higher education institutions must upload an Equivalence Certificate or Recognition Certificate obtained from the Council of Higher Education to the application system. (Except for Turkish citizens graduating from universities in Northern Cyprus.)
6. **Photo:** 2 passport-sized photographs.
7. **Copy of Turkish ID Card** (with original documents, sworn translation offices or Turkish translation approved by Turkish Foreign Representatives for international students)
8. **Criminal Record Certificate** (Documents obtained from e-Government are accepted)
9. **Resume/Curriculum Vitae (CV)**
10. **Military Status Certificate for male candidates** (Documents obtained from e-Government are accepted.)

**DOCUMENTS THAT MUST BE DELIVERED TO THE
INSTITUTE BY STUDENTS WHO HAVE EARNED THE RIGHT
TO ENROLL (FOR TURKISH CITIZEN STUDENTS)**

1. **Diploma:** For master's degree applicants, a bachelor's diploma or graduation certificate. (Applications can also be made with a Temporary Graduation Certificate or a graduation certificate obtained from the e-Government system.)
2. **Transcript:** Documents showing undergraduate courses and grades for master's degree applications.
3. **ALES Certificate:** ALES exam result document (**This document is not required for non-thesis master's programs and international applicants**).
4. **Foreign Language Certificate:** YDS or an equivalent exam result document. (**This document is required from applicants applying to master's programs that specify this requirement in the general application conditions**.)
5. **Institution Recognition Certificate:** For Turkish citizens or international applicants who completed their education at higher education institutions abroad, an Institution Recognition Certificate obtained from the Council of Higher Education (YÖK). (**Except for Turkish citizens who graduated from universities in the TRNC**.)

6. **Photograph:** 2 passport-size photographs.
7. **Copy of Turkish ID Card**
8. **Criminal Record Certificate** (Documents obtained from the e-Government system are accepted.)
9. **Resume/Curriculum Vitae (CV)**
10. **Military Service Status Document for male applicants** (Documents obtained from the e-Government system are accepted.)
11. **Residence Certificate**
12. **Student Commitment Letter**

CRITERIA FOR APPLICATION AND ADMISSION OF INTERNATIONAL STUDENTS

The following documents must be scanned and uploaded to the system during the online application. Candidates must bring the originals of the documents uploaded to the system with them during the exam/interview.

1. **Diploma:** For master's degree applicants, a bachelor's degree diploma or graduation certificate. (You can also apply with a Temporary Graduation Certificate or a graduation certificate obtained from e-Government.) (with original documents, sworn translation offices, or Turkish translation approved by Turkish Foreign Representatives)
2. **Transcript:** For master's degree applications, documents showing bachelor's courses and grades (with original documents, sworn translation offices, or Turkish translation approved by Turkish Foreign Representatives).
3. **Equivalence/Recognition Certificate:** Turkish citizens who have completed their education in foreign higher education institutions must upload an Equivalence Certificate or Recognition Certificate obtained from the Council of Higher Education to the application system (Except for Turkish citizens graduating from universities in Northern Cyprus). No equivalency certificate is required for the admission of foreign applicants to graduate programs. A school recognition certificate stating that the graduated undergraduate education institution is recognized by the Higher Education Institution is sufficient. They can take the recognition certificate online from the Council of Higher Education at <https://okultanima.yok.gov.tr/>.
4. **Document proving that you know Turkish (e.g. TÖMER...):** To enroll in graduate programs where the language of instruction is Turkish, foreign students are required to

provide proof of their Turkish language proficiency. Foreign students who have graduated from a program taught in Turkish at a higher education institution in Turkey are exempt from the Turkish language requirement. Apart from this, to begin their graduate studies, candidates must hold a certificate demonstrating at least a B2 level of Turkish proficiency from language exams such as TÖMER, DİLMER, or TYS. At the request of the departments, this required score may be increased. Candidates of Turkish proficiency from exams such as TÖMER, DİLMER, or TYS who do not possess a certificate demonstrating at least the B2-level are required to take the Turkish proficiency exam administered by the university. Candidates who achieve the B2-level in this exam are accepted into the program and may begin their courses. Those who fail the exam are directed to Alanya University's Turkish preparatory program, which lasts for a maximum of two years, after which they must obtain a B2-level Turkish proficiency certificate. Foreign graduate student candidates who fail in Turkish language proficiency after this training will have their registrations canceled at the end of two year. **(Students are required to submit a petition to enroll in the preparatory class and sign a commitment letter to provide a proficiency certificate at the end of the semester.)**

5. **Foreign Language Certificate:** Foreign language proficiency is required for international students who will enroll in graduate programs conducted entirely in English. Applicants who graduated from undergraduate or graduate programs taught in the same language as the program they are applying to (English), in countries where English is the native or official language, are exempt from submitting a foreign language proficiency certificate.
6. Applicants who cannot submit any of these documents are required to take the foreign language exam administered by the university. Applicants who score 55 or above on this exam are considered successful, accepted into the program, and may begin their coursework. Those who are unsuccessful are directed to Alanya University's foreign language preparatory programs for up to two years. International graduate applicants who also fail the foreign language preparatory program will have their registrations canceled at the end of two years. **(Students are required to submit a petition to enroll in the preparatory class and sign a commitment letter to provide a proficiency certificate at the end of the semester.)**
7. **Passport photocopy (The original documents along with their Turkish translations certified by a notary or Turkish foreign representatives).**

**DOCUMENTS REQUIRED TO BE DELIVERED TO THE
INSTITUTE BY INTERNATIONAL STUDENTS WHO HAVE
EARNED THE RIGHT TO ENROLL**

According to the Alanya University Directive on Application, Admission, and Enrollment of International Students to Graduate Programs: ARTICLE 7 – (1) For final registration to graduate programs, international students must submit the following documents to the Institute Directorate:

1. **Institution Recognition Certificate approved by the Council of Higher Education (YÖK)** for international student applicants.
2. **Equivalency Certificate for Turkish citizens who completed their education abroad.**
3. **Diploma from the institution of graduation** (original and a Turkish-translated copy approved by the Republic of Türkiye Embassies/Consulates or a notary)- **If submitting a photocopy, the original must be presented for verification.**
4. **Transcript from the institution of graduation** (original and a Turkish-translated copy approved by the Republic of Türkiye Embassies/Consulates or a notary)- **If submitting a photocopy, the original must be presented for verification.**
5. **Identity Document or Passport:** The page showing identity information (original and a Turkish or English-translated copy approved by the Republic of Türkiye Embassies/Consulates or a notary)- **If submitting a photocopy, the original must be presented for verification.**
6. Bank receipt showing that the tuition fee has been paid or a scholarship certificate.
7. **Residence Permit: Student visa** obtained from the **Republic of Türkiye Embassies/Consulates or a valid residence permit.**
8. **Residence Certificate**
9. **Foreign National Identification Number (YKN)**
10. **Two (2) passport-size photographs**
11. **Resume/CV** (detailed and written in Turkish or English)
12. **Student Commitment Letter**

13. General Health Insurance: International students who have entered or will enter Türkiye are required to obtain and document General Health Insurance (GSS) during university registration.

14. Foreign Language Proficiency Certificate: International applicants who wish to enroll in graduate programs in which the medium of instruction is entirely English are required to provide proof of language proficiency in the language of instruction of the program to which they are applying. Applicants who have graduated from undergraduate or master's degree programs conducted in English and located in countries where English is the native or official language are exempt from this language proficiency requirement.

Applicants who are unable to submit any of the required language proficiency documents will be required to take the foreign language proficiency examination administered by the University. Candidates who score 55 or above on this examination will be considered successful, admitted to the program, and allowed to commence their studies. Candidates who fail the examination will be directed to the foreign language preparatory program of Alanya University for a maximum period of two years. Enrollment in the foreign language preparatory program is subject to an additional fee. International graduate applicants who fail to achieve the required level of proficiency after completing the foreign language preparatory education will have their registrations deleted at the end of the two-year period **(Students are required to submit a petition to enroll in the preparatory class and sign a commitment letter to provide a proficiency certificate at the end of the semester.)**

15. Turkish Proficiency Certificate: International applicants who wish to enroll in graduate programs where the medium of instruction is Turkish are required to provide proof of Turkish language proficiency. International students who have graduated from a Turkish-medium program at a higher education institution in Türkiye are exempt from this requirement. All other applicants must submit a certificate demonstrating Turkish language proficiency at a minimum level of B2, obtained from recognized examinations such as TÖMER, DİLMER, or the Turkish Proficiency Exam (TYS), in order to commence their graduate studies. Upon the request of the relevant department, a higher level of proficiency may be required. Applicants who do not possess a Turkish language proficiency certificate at a minimum B2 level from examinations such as TÖMER, DİLMER, or TYS will be required to take the Turkish language proficiency examination

administered by the University. Candidates who successfully achieve B2 level proficiency will be admitted to the program and may begin their studies.

Candidates who fail to demonstrate B2-level proficiency will be directed to the Turkish Preparatory Program of Alanya University. The maximum duration of study in the Turkish Preparatory Program is two years, and students are required to obtain a B2-level Turkish language proficiency certificate within this period in order to continue their graduate studies. Enrollment in the Turkish Preparatory Program is subject to an additional fee. International graduate applicants who fail to satisfy the B2-level Turkish language proficiency requirement by the end of the maximum two-year period will have their registrations deleted **(Students are required to submit a petition to enroll in the preparatory class and sign a commitment letter to provide a proficiency certificate at the end of the semester.)**

16. International applicants for master's or doctoral programs who apply with a scholarship under the "Türkiye Scholarships" program are admitted directly to the relevant graduate programs without a scientific examination. However, such students must fulfill the required English or Turkish language proficiency conditions before beginning graduate coursework.
17. Except for non-thesis master's programs, students may not register for or continue more than one graduate program simultaneously.

Conditional Admission ARTICLE 8 – (1) International applicants who cannot provide any of the foreign language proficiency documents (e.g., Alanya University School of Foreign Languages English Proficiency Exam, Alanya University TÖMER Turkish Proficiency Exam) may be conditionally admitted to the program upon the decision of the relevant Graduate School Administrative Board (EYK). Conditionally admitted students must complete their missing documents within two (2) semesters.

(2) Students who complete the missing documents within the period specified in paragraph 1 will have their status converted to regular student status at the beginning of the following semester. Courses already taken by these students will be transferred to their registered program upon the decision of the EYK. (3) Students who fail to complete the missing documents within the given period will have their enrollment terminated by the decision of the EYK.

***Candidates may be asked to verify the information and documents submitted during the application process, or the University may investigate their accuracy. If any inconsistency is found in the information or documents, the candidate's admission to the program will be canceled, even if they have already been accepted!! The list of applicants whose applications are deemed eligible will be published on the official website of the Institute.**

1. All results (primary/alternate, successful/unsuccessful candidates, etc.) will be announced through the application system in accordance with Law No. 6698 on the Protection of Personal Data. Additionally, the lists will not be publicly disclosed.
2. For Thesis Master's Programs, candidates up to five (5) times the quota will be invited for the written and/or interview exam.
3. Non-Thesis Master's Programs will not conduct exams (written and/or interview). Ranking will be determined by the application system based on graduation averages.
4. In accordance with the decision of the Council of Higher Education, the validity period of the ALES and YDS exams is five years.
5. As it is not permitted to enroll in more than one thesis-based master's program simultaneously, candidates who are accepted as students will not be enrolled in the Institute if they are registered in another higher education program at the same level. It is the responsibility of the student candidates to deregister from any previously enrolled higher education program.
